SUBJECT: Changes in administrative arrangements in respect of contract

employment in the Public Service

You would recall that my Circular Memorandum dated January 18, 2013, on the subject above, made provision for salaries and other terms and conditions for specified positions, on contract, in the legal stream, among others. Among the terms approved for certain of those legal positions are a Subsistence Allowance and a Special Allowance. In this regard, it has been brought to my attention that in some Ministries/Departments, the provisions of the Subsistence Allowance are not being applied in accordance with existing policy.

- 2. Accordingly, it is necessary to clarify that the Subsistence Allowance is only payable in the following circumstances:-
  - (i) when an employee, in the course of official duties, travels a specified distance from his/her official headquarters and it becomes necessary to purchase a meal(s); and
  - (ii) in the case of a person employed in Trinidad, when on duty in Tobago, and vice versa, in the absence of the provision of any meal(s).

These are the same criteria which applied to the payment of the allowance prior to the standardization of the terms and conditions for persons, on contract, in the legal stream. The usual accounting procedures should apply in processing claims for the Subsistence Allowance.

- 3. In order to facilitate the proper application of the Subsistence Allowance, templates of the contracts to be used when legal officers **only** are employed, on contract, are set out at Appendices 1 and 2. (The conditions of Contracts set out at Appendix 4 of my Circular Memorandum dated January 18, 2013, as appropriate, as well as the List of Duties of the person engaged, must be appended to the contracts when executed.)
- 4. You would note that the template also makes provision for the payment of the Special Allowance. This allowance is only applicable to certain positions, so that care must be taken to ensure that the individual in respect of whom a contract is being prepared is eligible for the allowance.
- 5. Finally, I am to advise that where Transport Facilities have been approved for persons employed, on contract, the maximum sum to be advanced to effect repairs to the motor vehicle of the persons engaged is \$20,000.
- 6. I should be grateful if you would bring the contents of this Circular Memorandum to the attention of officers/employees in your Human Resource and Legal Units as well as any other officers/employees who are involved in the administration of contract employment.
