REVISED REMUNERATION FOR CHAUFFEURS IN THE EMPLOY OF CERTAIN OFFICE HOLDERS WITHIN THE PURVIEW OF THE SALARIES REVIEW COMMISSION

I wish to inform you that approval has been granted for the revision, with effect from 1st January, 1997 of the salaries and Cost of Living Allowance (COLA) payable to Chauffeurs in the employ of certain office holders within the purview of the Salaries Review Commission. The details are set out hereunder:

A. Personal Chauffeurs

The revised rate of salary for Personal Chauffeurs in the employ of holders of officers listed at Appendix I is as follows:—

- -\$2,250 per month with effect from 1st January, 1997
- -\$2,320 per month with effect from 1st January, 1998

B. Chauffeur Allowance

The Chauffeur Allowance payable to the undermentioned groups of office holders:

- (a) incumbents of Special and Similar Offices, covered by section 136(6) of the Constitution, section 5(5) of the Industrial Relations Act, Chap. 88:01 and section 5(5) of the Tax Appeal Board Act, Chap. 4:50, who were in service as at 31st December, 1994 and who retained the Chauffeur Allowance. (The list of offices is at Appendix II); and
- (b) office holders as at 31st December, 1994, who exercised the option given under the terms of Minister of Finance Circular No. 5 of 1995 dated 15th February, 1995, to retain the Chauffeur Allowance as personal to themselves. (The list of offices the holders of which had this option is at Appendix III)

has been revised as follows:

- (i) Where the Chauffeur
 Allowance was equivalent
 to the minimum basic
 salary of a Chauffeur I
 in the Public Service
- \$2,115 per month with effect from 1st, January, 1997 and \$2, 178 per month with effect from 1st, January, 1998
- (ii) Where the Chauffeur
 Allowance was equivalent
 to the minimum basic
 salary of a Chauffeur II
 in the Public Service
- \$2,245 per month with effect from 1st January, 1997, and \$2,312 per month with effect from 1st January, 1998

C. Cost of Living Allowance (COLA)

The revised rate of COLA payable to Personal Chauffeurs and Chauffeurs employed by office holders who are eligible for the Chauffeur Allowance is \$50 per month in 1997 and 1998, respectively.

- 2. Ministries and Departments, in consultation with the Ministry of Finance, are to identify funds to meet the expenditure to be incurred in giving effect to the provisions for 1998 above and in respect of arrears for 1997.
- 3. Permanent Secretaries, Heads of Departments/Statutory Authorities and the Chief Administrator, Tobago House of Assembly are requested to bring the contents of this Circular to the attention of the office holders to whom they are applicable.
