SUBJECT: Increase in the contributions to the UNIMED

Group Health Plan (monthly-paid):

You will recall that in my Circular Memorandum dated March 25, 2004, you were informed of the introduction of a contributory Group Health Plan with effect from April 01, 2004 for monthly paid officers of the Civil Service, the Tobago House of Assembly and those Statutory Authorities subject to the Statutory Authorities Act, Chapter 24:01 for which the Public Services Association is the appropriate recognized Association. By Circular Memorandum dated April 30, 2004, you were also informed that the Plan was introduced for holders of certain offices which fall under the purview of the Salaries Review Commission. These offices were listed in Appendix I to the Circular Memorandum and an updated list is reproduced in the Appendix hereto. The Plan, referred to as the UNIMED Plan (monthly paid), was later extended to members of the Teaching Service with effect from January 01, 2005.

- 2. There has been an increasingly high level of utilization of the Plan as well as a steady increase in the cost of medical services/treatment. Consequently, in an effort to ensure that the Plan remains self-sustaining, it has become necessary to implement a revised rate of contribution to the Plan from the existing rate of \$52 per month to \$90 per month with effect from June 01, 2006. Contribution to the Plan will continue to be shared equally between the Employer and the employee: the cost to each party being \$45 per month.
- 3. As you are aware, the employee's contribution is made through a monthly deduction from salary in advance of the month of coverage. Since it is not now possible to begin making the increased deduction of \$45 from May 2006 salary, one (1) deduction totalling \$64 will be made from each eligible officer's salary in June 2006 for coverage for the months of June 2006 and July 2006 made up as follows:
 - \$19 (arrears in respect of June 2006) and \$45 (contribution for July 2006)

- 4. Further information regarding accounting procedures for the increased deduction and the payment of contributions will be communicated to you shortly by the Comptroller of Accounts.
- 5. The Plan continues to provide the existing package of benefits which includes basic features such as Dental, Optical, Medical, Surgery, Maternity, Accidental Death and Disability Benefits and a Major Medical Benefit limit of \$500,000 over a three year period.
- 6. Permanent Secretaries/Heads of Department/Heads of Statutory Authorities and the Chief Administrator, Tobago House of Assembly are asked to note that all other arrangements in respect of the UNIMED Plan (monthly-paid) as contained in my Circular Memoranda dated March 25, 2004 and April 30, 2004 continue to apply. Further, you should ensure that the contents of this Circular Memorandum are brought to the attention of all staff who are members of the Plan, including holders of offices listed in the Appendix hereto. In this regard, for the information of those officers of the Civil and Teaching Services who are represented by appropriate recognized Associations, I advise that this Circular Memorandum is being issued with the concurrence of the Public Services Association and the Trinidad and Tobago Unified Teachers' Association.
